CONDITIONS OF ENTRY

The "Emerging Artists" Art Exhibition supported by the Nannup Arts Council Inc. is open to all artists up to 25years living within the South West region of Western Australia.

- 1 The Exhibition will open at **4pm on Thursday 29th September 2016 and run to 4pm Monday 3rd October 2016.**
- 2 Individuals are invited to enter one or two artworks only. The work is to be original work of the entrant and is to have been made during the previous year preceding September 2016.
- 3 Work from commercial kits or plans are not eligible.
- 4 Completed **entry forms**, accompanied by the required fees, must be received in Nannup by **5pm Wednesday 21st September 2016.** Late entries will not be accepted.
- 5 **DELIVERY**— An entry ID label must be attached to the back of each work. Artworks must be delivered to the Garage Gallery between **10am and 12pm Wednesday 28th September 2016.** No works will be accepted after this date.
- 6 Any changes to title or prices must be made at least three days prior to exhibition.

- 7 Each work must be for sale. Asking price must include the **20% COMMISSION levied by the NAC Inc.**
- 8 All works must be suitably presented ready for exhibition, framed, supported or able to be blue tacked to wall or risk rejection by the selection panel.
- 9 Size of work should not exceed **1500mm width x 1500mm height. (1500mm depth if 3D)**
- 10 All works entered are subject to selection for exhibition. The NAC Inc. reserves the right to withhold work from exhibition.
- 11 **INSURANCE**— the NAC Inc. and the Garage Gallery accepts no responsibility for insurance whilst work is being held or on display at the Garage Gallery. Entrants are responsible for their own insurance.
- 12 **COLLECTION**— Works may be collected from the Garage Gallery only between **4pm — 5pm Monday 3rd October or 10am – 12pm Tuesday 4th October.**
- 13 **COPYRIGHT**—Copyright remains with the artist but the NAC Inc. and the Garage Gallery reserve the right to use reproductions for publicity, catalogue, archival publications and educational purposes.
- 14 **SALES**—Artists will be notified of work sold periodically throughout the exhibition. Once a work is sold it may be removed from the exhibition.
