TRIALS

Trial 1 - open to all age eligible players (Sunday 25 August 2019)

Required Attendees

All players who have nominated for selection, with the exception of those listed below:

The following players will not be required to attend Trial 1, and will automatically advance to Trial 2:

- 2018/2019 U18 State Team Travelling Members
- 2018/2019 U15 State Team Travelling Members now age eligible for U18

The following players will not be required to attend Trial 1, and will automatically advance to Trial 3:

- 2019 Winter Academy members
- 2019/2020 WA Women contracted players

Note: Individual arrangements may be made to assess Regional players remotely instead of them attending Trials 1 &/or 2.

Trial 2 (Sunday 1 September 2019)

Required Attendees

- Players selected from Trial 1
- 2018/2019 U18 State Team Travelling Members who have nominated for selection.
- 2018/2019 U15 State Team Travelling Members now age eligible for U18, and who have nominated for selection.

Trial 3 (Sunday 8 September 2019)

Required Attendees

- Players selected from Trial 2
- Regional players selected from Trial 2 or those who have been assessed remotely and invited to attend Trial 3
- 2019 Winter Academy members
- 2019/2020 WA Women contracted players
